End of Year Wrap Up

As the 2006-2007 school year comes to a close, it is appropriate to recap what we were able to achieve during the year and the challenges that lie ahead.

Fair Share Update

Senator Jim Roby, Donna Schulze, Joe Staub, Greg Smith, Rich Corkran, Cheryl McLeod, Dan Collins, MST A lobbyist Diana Saquella, and I were all present in Annapolis on May 17 when Governor O'Malley signed the legislation which gives us the right to negotiate "fair share" with the Board of Education. Although the bill that was passed was "clean" in that it had no amendments "grandfathering" non-members hired before the passage of the bill from paying their "fair share," some members of the elected Board of Education—including some that were endorsed by HCEA—do not support a "clean" bill and are in favor of "grandfathering."

Dan Collins and Marius Ambrose, HCEA's chief negotiators, will be negotiating with the Board of Education to determine what "fair share" will look like in Howard County. Until an agreement on "fair share" is reached with the Board, we will not sign the Teacher or ESP contracts. Stay tuned.

- With the exception of one school, there is at least one Rep in every building
- HCEA has active, viable committees
- HCEA Contracts will be funded
- Health care will continue being funded at a 90/10 ratio for the next three years
- HCEA has established a positive working relationship with the HCPSS Central Office and with Superintendent Dr. Sydney Cousin
- Membership has increased
- 86% of the respondents of the 2007 Job Satisfaction Survey indicated their confidence in the leadership at HCEA
- Member involvement and visibility increased
- HCEA initiatives led to the increase in opportunities for professional development for paraeducators.

My goal is to embed HCEA into every facet of the school system. Please let me know your ideas and how we can work together to achieve our goals and make HCEA a stronger organization and, ultimately, improve the conditions of our membership and the quality of education of the children of Howard County.
